(If this day falls on a Saturday during the month, the payment will process on the Friday before. If this day falls on a Sunday during the month, the payment will process on the following Monday.)

These authorized collections will continue until I give written notice to MonthlyCollector, LLC and MonthlyCollector, LLC has given me written confirmation of my cancellation request. I understand that I must give MonthlyCollector, LLC a written notice of cancellation at least 7 days before my next scheduled collection.

Under penalty of applicable laws, I state that I am 18 years of age or older, and I have legal authority and understanding to enter into this contract. I understand and agree that my personal and financial information is accurate and will be kept strictly confidential by MonthlyCollector, LLC; my information will not be accessible to any third parties. I understand and agree that I am 100% liable for services I render and that MonthlyCollector, LLC is in no way responsible for damages or liabilities caused by my services. I agree to settle any disputes, disagreements, or undelivered services between me and my clients without involving MonthlyCollector, LLC. I understand that MonthlyCollector, LLC does not guarantee my services and I am solely responsible to provide the agreed service with each of my clients according to my personal or business contracts and agreements.
